Individual contributions are limited to \$4,800 per federal election (\$2,400 for the pre-convention and \$2,400 for the general election), \$9600 per couple. Contributions made after May 21st are limited to \$2,400 per person, \$4,800 per couple. The pre-convention and general election are considered separate federal elections with each having a separate contribution limit of \$2,400. By signing this form below, you agree to designate the first \$2,400 of your contribution to the pre-convention election and any amount above \$2,400 to the general election. Federal multi-candidate political action committees (PACs) may contribute \$5,000 per election. Federal law requires political committees to report the name, mailing address, occupation and name of employer for each individual whose contributions aggregate in excess of \$200 in a calendar year.
